#### 1. 5:00 P.M. CALL TO ORDER

Mayor Pro-Tempore Douglas Lottridge called the meeting to order at 5:00 p.m.

## 2. INVOCATION AND PLEDGES OF ALLEGIANCE

Alderman Wayne Browning led all in prayer and Pledges of Allegiance.

#### 3. ROLL CALL AND CERTIFICATION OF A QUORUM

The motion was made by Alderman Browning and seconded by Alderman Lynn to adopt the agenda as presented. Motion carried unanimously.

The motion was made by Alderman Anderson and seconded by Alderman Harrison to approve the minutes of the Regular Meeting of September 18, 2012 as presented. Motion carried unanimously.

## 8. REPORT OR REQUEST(S) FROM CITY ADMINISTRATOR/DEPARTMENT HEADS

City Administrator Lynn Roberts reported to Council that Mr. William Krueger will be at the next Council Meeting to report on the new well and street study. Assistant City Administrator Shawn Jackson announced the Fall Cleanup will be from October 22 – 26 and will be a curbside pickup. Mr. Jackson also reported the dead trees have been cleared at Clark Park.

#### 9. CONSIDERATION OF RESOLUTION GRANTING CITY ADMINISTRATOR AUTHORITY TO SIGN CONTRACT WITH TXDOT FOR STEPHEN F. AUSTIN BUST AND ANY RELATED ACTION NECESSARY

The motion was made by Alderman Lynn and seconded by Alderman Browning to approve Resolution 1449 authorizing the submittal of an agreement to TXDOT stating the terms and conditions for the Gateway Monument project. Motion carried unanimously.

# 10. CONSIDERATION TO PERMANENTLY RESTRICT TRAFFIC ON NORTHERN MOST 5 FEET OF NORTH BELL AND ANY RELATED ACTION NECESSARY

The motion was made by Alderman Anderson and seconded by Alderman Harrison to adopt Ordinance 1451 to permanently close the northern most 5 (five) feet of North Bell to vehicular traffic as requested by the Bellville Economic Development Corporation. Motion carried unanimously.
