# MINUTES OF A REGULAR MEETING OF THE CITY COUNCIL

# **CITY OF BELLVILLE**

# 1. 5:00 P.M. CALL TO ORDER

Mayor Joe Ed Lynn called the meeting to order at 5:00 p.m.

#### 2. INVOCATION AND PLEDGES OF ALLEGIANCE

Alderman Wayne Browning led all in prayer and Pledges of Allegiance.

#### 3. CERTIFICATION OF A QUORUM

Present-to-wit: Mayor Joe Ed Lynn, Aldermen Douglas Lottridge, Wayne Browning, Daniel Poffenberger, Clay Kistler and James Harrison; thereby a quorum was established. Also present were City Administrator Shawn Jackson, City Secretary Betty Hollon and City Attorney Charley Smith arrived at 5:02 p.m.

#### CONSIDERATION TO ADOPT AGENDA

The motion was made by Alderman Browning and seconded by Alderman Lottridge to adopt the agenda as presented. Motion carried unanimously.

#### CONSIDERATION TO APPROVE MINUTES OF PREVIOUS MEETINGS

The motion was made by Alderman Lottridge and seconded by Alderman Browning to approve the minutes of the Regular Meeting of August 18, 2015 as presented. Motion carried unanimously. Alderman Lottridge asked that the word "additional" be struck from the minutes of the Special Meeting of August 27, 2015 on Agenda Item 6 and then motioned to approve the minutes. Alderman Kistler seconded the motion. Motion carried unanimously.

6. **PUBLIC HEARING**: THE CITY COUNCIL WILL RECEIVE PUBLIC COMMENTS CONCERNING PROPERTY TAX RATE OF \$0.2803 BEING CONSIDERED FOR TAX YEAR 2015.(THIS IS THE SECOND OF TWO PUBLIC HEARINGS.)

The Public Hearing opened at 5:03 p.m. Mr. James Elam commented on audit of taxpayer dollars. The Public Hearing closed at 5:05 p.m.

Alderman Browning inquired about Police Department involvement in "National Night Out" and about maintainer being operational.

#### 9. REPORT OR REQUEST(S) FROM CITY ADMINISTRATOR/DEPARTMENT HEADS

City Administrator Shawn Jackson reported Fall Clean-Up will be the week of October 19 – 23. It will be a curbside pickup.

10. CONSIDERATION TO APPROVE EDC GRANT OF \$5,000 FOR PROJECT WITH BELLVILLE LION'S CLUB FOR PLACEMENT OF "WELCOME TO BELLVILLE" SIGN ON HIGHWAY 36 NORTH AND ANY RELATED ACTION NECESSARY

The motion was made by Alderman Lottridge and seconded by Alderman Kistler to approve the \$5,000 EDC grant project with the Bellville Lion's Club for a "Welcome to Bellville" sign on Highway 36 North. Motion carried unanimously.

11. CONSIDERATION TO APPROVE 2015-2016 BELLVILLE ECONOMIC DEVELOPMENT CORPORATION BUDGET AND ANY RELATED ACTION NECESSARY

The motion was made by Alderman Lottridge and seconded by Alderman Browning to approve the 2015-2016 Bellville Economic Development Corporation Budget as presented. Motion carried unanimously.

12. CONSIDERATION OF 2014-2015 BUDGET AMENDMENTS AND ANY RELATED ACTION NECESSARY

The motion was made by Alderman Lottridge and seconded by Alderman Harrison to approve the 2014-2015 budget amendments presented by City Administrator Shawn Jackson. The adjustments were transferring funds from one department to another. Motion carried unanimously.

13. CONSIDERATION OF INCREASE OF GARBAGE RATES AND ANY RELATED ACTION NECESSARY

The motion was made by Alderman Browning and seconded by Alderman Harrison to approve Ordinance #1500 increasing garbage rates inside the city limits to \$20.00 and outside city limits to \$30.00 and increasing dumpster rates. Motion carried unanimously.

14. CONSIDERATION OF INCREASE OF PERMIT/INSPECTION FEES AND ANY RELATED ACTION NECESSARY

The motion was made by Alderman Lottridge and seconded by Alderman Kistler to approve Ordinance #1499 increasing inspection/reinspection fees and permit fees. Motion carried unanimously.
