1. 5 P.M. CALL TO ORDER

Mayor Joe Ed Lynn called the meeting to order at 5:00 p.m.

2. INVOCATION AND PLEDGES OF ALLEGIANCE

Alderwoman Jacob led all in prayer and Pledges of Allegiance.

3. CERTIFICATION OF QUORUM

Present-to-wit: Mayor Joe Ed Lynn, Aldermen Douglas Lottridge, Clay Kistler, John Moore, Alderwomen Cassie Janish and Donna Jacob; thereby a quorum was established. Also present were City Administrator Shawn Jackson, City Attorney Charley Smith and City Secretary Betty Hollon.

4. CONSIDERATION TO ADOPT AGENDA

The motion was made by Alderman Lottridge and seconded by Alderwoman Janish to adopt the Agenda for the Special Meeting of July 10, 2018 as presented. Motion carried unanimously.

5. CONSIDERATION OF REPLAT OF SOUTH FORTY SUBDIVISION, LOT 6, AND ANY RELATED ACTION NECESSARY

Mr. Glen Alexander presented the replat of Lot 6 in South Forty Subdivision. He explained additional restrictions of Lot 6 and a Form Survey must be provided to the City before pouring concrete.
